  - Identify and explain the political thinking that led to the American Revolution.
  - Analyze the political philosophy behind the desire for independence.
  - Analyze and explain the creation and evolution of the Constitution.
  - Identify and explain the rationale for the United States' Federal system of government.

- Explain the concepts of separation of powers and the system of checks and balances.
- Identify the manner in which the U.S. Constitution changes and continues to evolve.
- 2. Identify forms of political participation, differentiate among organizations engaged in elections, and analyze participation in US democracy. (Meets KBOR "Political Behavior" requirement.)
  - Analyze and identify what democracy is.
  - Analyze and explain the limitations of democracy.
  - Analyze and explain the various interpretations and implementations of democracy as a form of government.
- 3. Understand and analyze how policy decisions are made and the impact of policy on the public. (Meets KBOR "Public Policy" requirement.)
  - Identify and explain the role of the President.
  - Identify and explain the role of the Bureaucracy.
  - Identify and explain the role of the Congress.
  - Identify and explain the role of the Judiciary.
  - Analyze and identify the manner in which these institutions interact and react to each other in performing the functions of government.
- 4. Explain the origins and the evolution of United States Constitutional Democracy. (Meets KBOR "Constitution" requirement.)
  - Identify and explain how public policy is formed in the United States.
  - Describe how public opinion influences the actions of government at all levels.
  - Describe how ethnic and cultural diversity affects the political process in the United States.
  - Analyze and explain the role of the media in the political process.
