CYBER STALKING—Allen County Sheriff Brian Murphy and Deputy Anthony Maness cover the fundamentals of digital evidence on mobile devices—how mobile phones and other devices store data and how to isolate and preserve data to prepare for legally defensible extraction and analysis.

SEXTING—Crawford County Attorney, Michael Gayoso, Jr. discusses the growing and widespread practice of sexting and its long-term damage and legal ramifications.

HYBRID CARS/1ST RESPONDER SAFETY— John Settle, Kansas Fire & Rescue Training Institute conducts classroom and HANDS-ON training to ensure the safety of 1st responders (oftentimes LEOs) when responding to accidents involving hybrid vehicles.

LEGISLATIVE UPDATES—Ed Klumpp, Kansas Legislative Liaison, shares the changes to law passed by the 2014 Kansas Legislature affecting law enforcement operations. Emphasis will be on how those changes directly affect street officers and investigators.

SEIZING ASSETS—Robin Sommer, Assistant Attorney General, Special Assistant U.S. Attorney will be speaking on state/federal asset forfeiture. Students will learn how to: identify assets for forfeiture; seize and forfeit assets; and use forfeiture to enhance law enforcement departments.
