Labette Community College estimates to serve at least 410 students with the Emergency relief funds.

Methods used by Labette Community College to determine if a student is eligible to receive emergency relief funds.

Students must complete the COVID-19 Emergency Relief Fund Application (HEERF) posted on the labette.edu website.

Purpose: To provide emergency financial aid grants to students for expenses related to the disruptions of campus operations due to coronavirus (including eligible expenses such as food, housing, course materials, technology, health care, and child care)

Eligible students: Eligible for Title IV Funds (Pell Grant, Subsidized Direct Loans, Unsubsidized Direct Loans, FSEOG, and FWS) Students must have a 2020-2021 Free Application for Federal Student Aid on file with Labette Community College (FAFSA).

Student must be currently Degree and/ or Certificate seeking.

Students must making Satisfactory Academic Progress.

Courses must go toward student's declared major or certificate.

Students who were enrolled exclusively in an online program on March 13, 2020, the date of the President's Proclamation, "Declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) Outbreak" are not eligible for emergency financial aid grants.

Frequency of Payments: One time payments will be made directly to the students that qualify.

Funds will continue to be disbursed until all funds have been depleted. Grants will be awarded on a first come first serve basis. Labette Community College can make adjustments to this plan as seen needed to benefit students that have been impacted by the disruptions of campus operations do to coronavirus.

How HEERF Grants will be calculated based on the following information:
