#### **Nursing Program**

Dr. Bohnenblust said eight.

#### **Policy Approval**

Trustee McReynolds moved to approve the revisions to Policy 1.14 – Strategic Planning. Trustee Hoskins seconded and motion carried 5-0.

#### **Revenue Neutral Rate Resolution**

Leanna Doherty reminded the Board members that LCC has had no mill levy increase for 18 years. Trustee Hoskins moved to approve the revenue neutral rate resolution and Trustee Taylor seconded. Motion carried 5-0. Leanna Doherty carried the resolution to each Trustee who approved the resolution for a signature.

#### College 2021-2022 Budget Approval

Trustee Winchell moved to approve the annual 2021-2022 budget. Trustee Taylor seconded and the motion carried 5-0.

#### Labette Community College Fiscal Year 2021 Annual Report

Dr. Watkins presented highlights from the annual report. Trustee McReynolds questioned some information in the report and Dr. Watkins stated he would clarify and send Trustees a revision.

#### Professional Staff Employment Letter

Chair Landrum moved to approve the professional staff employment letters for Heidi Flora, Executive Assistant to the President/Clerk of the Board, starting September 13, 2021, at a salary of \$30,000 and Laura Pyle, Workforce Allied Health Coordinator, starting September 20, 2021, at a salary of \$35,900. Trustee McReynolds seconded and motion carried 5-0.

#### Policy Review

Dr. Watkins presented two policies for review. Tammy Fuentez spoke on Policy 3.03 Catalog and Dr. Sharp spoke on Policy 3.36 Hybrid Courses.

#### Change Orders to the Athletic Expansion Project

After discussion, Trustee McReynolds moved to approve the change orders as presented. Trustee Hoskins seconded and motion carried 5-0.

#### Approval of Bills

Trustee McReynolds moved to approve the Claims Register. Trustee Taylor seconded and motion carried 5-0.
