Adoption of Agenda (ACTION ITEM)

Student Government Report:

Harrison Hall, Student Life Specialist, provided a written report.

Administrative Report:

Comparison of Expenditures to Budget – The October financial report was placed on the tables. At the end of October, we were 33% through the year. The general fund was 33% expended and the technical education/vocational fund was 28% expended. Vice-President Doherty invited questions from the Trustees.

Facility Report:

There was no facilities report.

President's Report:

At the start of the meeting, Dr. Watkins introduced Elizabeth Robinson as the new Student Success Center Director.

Dr. Watkins shared a written report provided by Tyler Allen, Director of Admissions, with an update on the Fall 2023 recruitment efforts. It was reported that enrollment is currently up 6.89% (48 students).

Leanna Doherty, Vice-President of Finances, provided a printout with a breakdown of the HVAC expenses for the athletic complex over the past several years.

Dr. Watkins provided information regarding the reclassification process the college will soon be conducting through the Arnold Group.

Board Members were provided with the current form utilized for the president's evaluation and asked to take some time to review it and give any recommendations for changes to Dr. Watkins or the Board Clerk.

Dr. Sharp gave an HLC update consisting of the January 29, 2024, multi-site visit and the ten-year affirmation visit which will be conducted in March 2-3, 2026.

Policy Approval

Trustee Howerter moved to approve the revisions to Policy 4.01 Admissions/Enrollment Eligibility. Trustee Landrum seconded the motion and the motion carried 6-0.

Administrative Employment Contract Approval

Trustee Landrum moved to approve the Administrative Contract for Kelly Kirkpatrick, Vice-President of Student Affairs, at a salary of \$90,000 to begin November 13, 2023. Trustee Hoskins seconded the motion and the motion carried 6-0.

Professional Staff Employment Letter

Trustee Landrum moved to approve the professional staff employment letter for Henrietta Wyland, Academic Advisor, at a salary of \$32,900 to begin October 31, 2023. Trustee Taylor seconded the motion and the motion carried 6-0.

New Course Approval

Trustee Hoskins moved to approve the Culture & Ethnicity and Educating Exceptional Students courses to begin Fall of 2024. Trustee Landrum seconded the motion and the motion carried 6-0.

Purchase of Anatomage Table

Trustee Taylor moved to approve the sole bid of \$115,485 for the purchase of an Anatomage table and four tablets. Trustee Landrum seconded the motion and the motion carried 5-0. Trustee Howerter abstained from voting.

Approval of Bills

Trustee Landrum moved to approve the Claims Register. Trustee Dantic seconded the motion and the motion carried 6-0.
